

Who We Are

Tender Hearts Foundation is the leading heart and mind charity for underprivileged women. We are committed to giving every underprivileged woman and young girl a voice. We work in the space deemed as poor, indigent, unsuitable and uncultured, helping women and young girls tackle the barriers they face and supporting them to create empowering lives for themselves, their families and the community. We are registered with the Corporate Affairs Commission (CAC) and Lagos State Ministry of Women Affairs and Poverty Alleviation.

Why We Do What We Do

We recognize that the underprivileged women and girls are disproportionately affected by poverty and discriminations and suffer abuse mentally and violations in the realization of their rights, entitlements and access to central resources. Our experience has shown us that when equipped with the proper resources, women and young girls have the power to transform their own lives and help their entire family, hence readdressing the cause of poverty and social injustice in the community.

Our Mission

Our mission is embedded in our mandate which is to empower underprivileged women and young girls through relevant education, skills development, innovative health care and focused livelihood programs.

Our Ethos

At Tender Hearts Foundation we are:



Heart Led

With our hearts, we reach and search out for the underprivileged women and young girls who need the most help. We have found these to be widows, abused women suffering from domestic violence, single mothers and young girls that have found themselves on the streets. In the last 2 years, we have reached **over 500 women.**

Mind Led

We believe that educating the mindset and advocating for the correct mind set is key to empowering underprivileged women and young girls. We design, develop and deliver programmes that reshape the mindset, enabling underprivileged women and young girls to believe in potentials within them, the power to speak, the power to do great things, the power to be a significant and positively contributory citizen.

Hand Led

We believe that every hand must be empowered to generate income. We train women and young girls on how to identify their strengths, a trade, a skill or education and how to ensure that that their hands strive for good.



Our Values

At all three levels (heart, mind and hands) we encourage and enforce our four organisational values.



Respect

We take time to listen to underprivileged women, young girls, each other and to the people and communities we work with, because we believe everyone's voice deserves to be heard and treated as important.

Enabling

We give everyone we work with the chance to be empowered; we believe that no woman or young girl should be classed lower than any; and everyone, if giving the chance, has what it takes to voice out their dreams, to live an empowered life and to contribute to the society.

Courage

We are driven by our commitment to make life better for the underprivileged woman and young girls; we hold ourselves accountable to our aims and objectives and build into the lives of the women and girls, courage to be self independent. This is the courage and ability to speak, act, reclaim and rebuild their lives even in the face of fear and uncertainty.

Accountability

We enshrine accountability and transparency into all that we do; upholding integrity at all times. Our charity has worked in Nigeria since October 2018, focusing on alleviating poverty and the empowerment of women and young girls.

Our Goals and Objectives

- We deliver skill development training programs for women and young girls in our society
- We work with adolescent girls to protect their health and rights by providing them access to sexual and reproductive health counselling, information and services; comprehensive sexuality education
- We co-operate and assist in suitable joint venture with the Governmental Organizations and agencies seeking the goal of redressing poverty and improving health status of women
- We organize women empowerment, capacity and skills development programs aimed at enabling them to become economically and socially independent
- We provide immediate and emergency help in crisis



Programmes and Projects

Equipping underprivileged women and girls. We believe it has a ripple effect. For us, we just do not want to feed people with fish, we want to train and skill them up to catch fishes themselves. We uplift and upskill to create a **ripple effect**.



Woman of Purpose (The Foundation's Annual Event - An Empowerment Program)

Tender Hearts Foundation has embarked on self- actualization schemes and skills development programs for indigent women, girls and widows across Nigeria. It involves teaching and providing basic support for women in different communities through production of domestic items like candles, soaps, beads, hats, catering, perfume, dettol, shampoo, fashion designing, grinding machines, sewing machines, saloon equipments etc. These beneficiaries have become entrepreneurs on their own and are encouraging and training others towards self- resourcefulness. We also hold an annual event known as Woman of Purpose where we focus on training and equipping women and young women with life skills. This programme extends to providing funds for learning a trade or setting up a trade followed by a mentoring programme.

Ripple Effect... Why?

We genuinely believe that by enabling vulnerable women and girls, we add value to the foundation of our society, we stand a better chance of creating a better nation and a better society including a better chance of creating -"A world safe for every child as set out by the UNICEF. Our stance on this matter is that women and girls are the bedrock and main carers in our society and by empowering them to live dignified and independent lives; this consistently trickles down into the life of every child, creating stable homes and stable lives for thousands of children.





International Women's Day Celebration (March 8th)

Tender Hearts Foundation recognises auspicious days as this to celebrate the girl child, advocate for better living, gender balance and speak up against boring stereotypes as related to women. We hold seminars, workshops, debates and colloquial discussions and campaigns/health talks to continue in upholding the stance and importance a woman is entitled to in her environs and the society at large. In some cases as decided by the THF team, freebies like sanitary pads, detergents, antiseptics and disinfectants are given to females in celebration of this day. Hence, much more can be achieved with your donations and support.

International Widows Day (June 23rd)

On 21st December 2010, the United Nations General Assembly formally adopted 23rd June as International Widows Day, endorsing by unanimous acclaim, a proposal introduced by President Ali Bongo Ondimba of Gabon. As well as formally recognizing 23rd June as a day of observance, the accompanying resolution called upon "Member States, the United Nations system and other international and regional organizations to give special attention to the situation of widows and their children". In the same stead, Tender Hearts Foundation adopted this day to raise awareness of the issue of widowhood. One of the foundation's key goals is to highlight what it describes as an unforeseen calamity and





provides means of help for the women living in widowhood and suffer from in-laws abuse, maltreatment, rejection and economic deprivation purely because they have lost their husbands.

'Face of Giving' (December)

'Face of Giving' is a Tender Hearts foundation initiative to put smiles on the face of indigent women and widows during the festive season. We tagged it 'The Face of Giving' because it's a time that we encourage people to give no matter how small it is so the festive season can be felt in families that are poor also. The program is set to prioritize and support indigent women and widows by relentlessly putting smiles on sad faces and so much more for homes and families. In this season of love and festivity, surprise gifts like gift packs, food items, clothes, shoes etc. are given out to these women and their families and are encouraged to continue to stay hopeful and engage in activities that help sustain and make better their lives.

Health Outreach Program

No fewer than 3000 persons have so far benefited from Tender Hearts Foundation sponsored medical outreach across communities in Nigeria.

It is a week-long medical outreach, with items like free insecticide treated nets to repel mosquitoes; as well as anti-malaria drugs, multivitamins and other drugs for common illnesses, sanitary pads for young girls and delivery kits for pregnant women.

Others are free HIV test, counseling and awareness talk, blood sugar level checks, malaria, hepatitis tests and dental checks.

Youth Engagement and Inclusion Program (Women Folkhood Sensitization and Awareness Program)

This is an event that aims to reflect the "woman synergy" and strength" as a team, working together to tackle pertinent issues bothering around women and young girls through educative and enlightenment programs which may be outreaches, seminars, awareness rallies, round-table discussions etc. These programs are mostly held in partnership with the Lagos Government Education Authority, Lagos Island. Lagos State, Nigeria.





Skill Acquisition Workshop Internships

The skill acquisition internship programmes is powered by The Lagos State Government, through the Ministry of Women Affairs and Poverty Alleviation (WAPA), in conjunction with registered women NGOs like Tender Hearts Foundation. It is targeted at over 500 widows across the state, to train and empower young widows in various vocational skills ranging from hair braiding and weaving, gele-tying and makeup application, fabric stoning, catering and food preparation, production of soap, pomade and stove wick, customised throw pillows, interior accessories, Ankara craft and leatherworks amongst others. It is a free training put in place to ensure that, this category of women avail themselves of this opportunity of acquiring valuable skills in order to be self-dependent.

Conclusion

We are compassionate and committed. All our programmes are geared towards:

- Building capacity towards independent living
- Equipping women and young girls with lifelong skills for trading and livelihood
- Building self-confidence, dignity and strength geared towards being responsible and contributory citizens
- Providing emergency and immediate provision in response to group and individual needs;

 Giving women and girls a meaningful and contributory voice in the society through a range of awareness campaigns.

We believe that:

- Every widow should have the opportunity to rebuild their lives, to be self-reliant in a trade or a job, and be enabled to bring up responsible children
- Indigent women must be supported to live dignified lives, which include having a trade or a job
- Women (particularly young women) who have been subject to abuse, must be supported to rebuild their lives, attain skills and live dignified contributing and giving back to the society
- Where a widow, an indigent woman or a girl that has suffered abused has an immediate and emergency need particularly in the areas of health, mental, nutrition and education, well-being, this should be met
- The voice of women and girls should be heard

Our Chairman

H.I.M Oba Adeyeye Enitan Ogunwusi, Ojaja II

His Imperial Majesty, Oba (Dr.) Adeyeye Babatunde Enitan Ogunwusi (Ojaja II), is a Nigerian monarch. He is the 51st and current traditional ruler, or Ooni, of the Yoruba kingdom of Ile-Ife. He was proclaimed as Ooni in 2015, holding the regnal name Ojaja II succeeding the deceased Oba Okunade Sijuwade.

He started his elementary education at Subuola Memorial Nursery and Primary School, Ibadan and Ibadan District Council, Akobo, Ibadan. He then proceeded to the prestigious Loyola College, Ibadan and later to St. Peters Secondary School, Ile-Ife, where he received his secondary school certificate (SSCE). He graduated as an accountant from The Polytechnic, Ibadan.

He is a member of the Institute of Chartered Accountants of Nigeria. He is also an Associate Accounting Technician. Oba Ogunwusi is a certified member of the Institute of Directors. He is also a member of the Global Real Estate Institute. He holds a number of honorary doctorate degrees: one in Public Administration from the University of Nigeria, Nsukka and another in Law from Igbinedion



University. He is the Chancellor at the University of Nigeria, Nsukka.

Oba Adeyeye Enitan Ogunwusi is the Founder and Chairman of Gran Imperio Group, the holding company of Real Estate and Construction, Manufacturing, Facilities Management, Leisure and Tourism companies in Nigeria. He has been involved in Engineering, Procurement and Construction (EPC) locally and abroad for over 13 years and also actively involved in the development of over 2,500 housing units with various consortia of developers/ promoters over the last 9 years in Nigeria. He facilitated strong trade relationship through Association for International Business (AIB) with presence in over 200 member countries across the globe which he set up in Nigeria. One of the key achievements of this body is the trade facilitation between the United Arab Emirates (Jebel Ali free Trade Zone Development) and Federal Government of Nigeria through Nigerian Investment Promotion Commission (NIPC). He was involved in the facilitation and development of Sparkwest Steel Galvanizing Plant (the only Steel Galvanizing Plant in Nigeria), National Iron Ore Mining Company Limited and Jakura Mines resuscitation projects, which has eventually become the major limestone feed stock to Obajana Cement Plant in Kogi State, Nigeria.

Oba Adeyeye Ogunwusi was involved with trading and marketing of commodities, the main facilitator for Dangote Group's break into the "up-country supply chain consortium" between 1996 and 1999. He also traded for Dohagro Allied, Global Apex, Olam, Clemco, Stallion Group, Milan Group etc, at about the same period.

ObaAdeyeye Ogunwusi was selected from the Giesi Ruling House of Ile-Ife, amongst indigenes who were also heirs to the throne on 26 October 2015. He received his staff of office on 7 December 2015. He has been described as an 'astute entrepreneur driven by the need to turn impossibilities into possibilities.

Oba Ogunwusi is the spiritual leader of the Yoruba people now saddled with the responsibility of making supplications to God and the Òrìsà on behalf of his tribe and the world at large during annual festivals such as Olojo. Shortly after his coronation, Oba Ogunwusi met with the Alaafin of Oyo and by so doing initiated a new era in the history of the Yoruba States. He effectively broke the jinx of institutionalised discord between the thrones that had plagued Ile-Ife and Oyo for decades. He is a multiple award winner for his ability to call for peace and unity across the nation and an advocate for the empowerment and emancipation of women and young people. He has transformed Ile-Ife into a tourist zone, with changes including the beautification, redesign and re-construction of the ancient city.

Oba Ogunwusi is also a renowned philanthropist who is committed to humanity and an advocate for the less privileged. He has granted support over the years through the House of Oduduwa Foundation and, recently, through Hopes Alive Initiative. On 12th June 2016, Ooni Ogunwusi was presented with the key of the County of Somerset, Franklin Township, New Jersey in the United States as H.I.M was honoured with the proclamation of the Town of Franklin.

Oba Ogunwusi was born on 17 October 1974 to the family of Oluropo and Wuraola Ogunwusi of the Giesi Royal House, Agbedegbede Compound in the city of Ile-Ife. It was said that his birth was predicted years before he was conceived, Hence, the name Enitan was given by his mother while his grandfather named him Adeyeye, which means 'the crown befits the throne. He is the fifth child in a family of seven.

Oba Adeyeye Babatunde Enitan Ogunwusi is married and blessed with children.

Sally Othihiwa is a lawyer who started her career in litigation. However, as a young lawyer her interest was in the real estate, and has made her mark over the years in property law. In 2014, she was appointed a Notary Public. She is an active member of the NBA, Chartered institute of Arbitrators, a member of NBA Section of business law and an active member of the construction committee who has made significant contributions to the building and development of the Bar.

As the Managing Director of AUZ Group of companies, she has garnered over 17 years experience in the real estate industry. The company also focuses on Legal documentations, facility management, development, construction and oil and gas.

Amb. Sally is an inspiration and example to women everywhere who are balancing responsibilities both inside and outside their homes. She is committed to empowering women, children, and families to connect and grow strong with a foundation of faith in Jesus Christ, with passion for God. She is one of the presidents of a leading women's fellowship from where the inspiration to set up the NGO came from. With her interactions with the indigent folks in the society she realized all that the class of people need is help and support.

She is a UN Ambassador for Peace, Justice & Human Rights and has received many International awards from both churches and organizations through her benevolent services. She is also a Lady of Saint Christopher of the Anglican Communion. Amb. Sally loves to restore opportunities that once seemed lost forever and sometimes bring those opportunities back in ways she haven't considered or wasn't looking for.

She is a lover of God, and she is married to Sir (Hon.) Ayodele Othihiwa; and they are proud parents of intelligent and God-fearing children.



Ekemejero Ohwovoriole

Ekemejero Ohwovoriole, SAN was called to the Nigerian Bar in March, 1995 and posted to the Chambers of Mrakpor & Oju in Lagos for his mandatory National Youth Service (NYSC), where he worked as a Counsel from 1995 to 1996. After his national youth service, he started his legal practice with the reputable chambers of Chief M. P. Ohwovoriole, SAN, also in Lagos State, where he imbibed the rudiments of legal practice that have proved priceless over the course of time. He proceeded to obtain a masters degree in Law from the University of Lagos, Lagos State in 1998.

Whilst engaged in practice as a full-service legal practitioner, Ekeme was also a part-time lecturer between 1999 and 2003 at the Lagos Campus of the Delta State University/ Maryland Campus of Lagos State University. As fate would have it, he was called in 2003 by the then Honourable Attorney-General and Commissioner for Justice of Delta State, Prof. A. A. Utuama, SAN, to serve as his Special Assistant from 2003 to 2007. As Special Assistant to the Honourable Attorney-General. Ekeme represented Delta State in several precedents setting constitutional cases at the Court of Appeal and at the Supreme Court. He declined opportunities to continue with political appointments in 2007 and returned to full time legal practice as the Principal of Aequitas Chambers, a fullservice law firm with head office in Asaba, Delta State and branch offices in Lagos and Abuja. Upon his return to fulltime private practice, Ekeme partnered with leading lights in the legal profession in Nigeria to prosecute and defend numerous high-octane election petitions, civil, and criminal matters at all levels. He has made his mark over the years as a first-rate criminal law, election law and commercial law practitioner. In 2005, he was appointed a Notary Public and was elevated to the prestigious rank of Senior Advocate of Nigeria in 2017 as a mark of excellence.

The learned Silk is a very active member of the NBA Asaba Branch, and he has made significant contributions to the building and development of the local Bar Center in addition to other activities of the Branch. He is an advocate for continuous legal education of lawyers and he has walked the talk by sponsoring seminars and professional courses for Continuing Legal Education of the members of the legal profession in his branch and professional colleagues with

whom he is associated. He served as a member of the National Executive Committee (NEC) of the Nigerian Bar Association from 2010 to 2017 under four consecutive administrations. During which period he also served as a member of several strategic committees such as the Judiciary Committee in 2010, the Rules and Practice Committee in 2015 and the Administration of Justice Committee in 2016.

The learned Silk abhors injustice and as far back as 1997, he was a member of the Human Rights committee of the NBA, Ikeja Branch. Since he established AEQUITAS Chambers, he has and continues to offer pro-bono services to deserving organizations and indigent members of the society whenever the need arises. He is a member of; the International Bar Association, the Nigerian Norwegian Chamber of Commerce, the Asaba Chamber of Commerce, Industry, Mines and Agriculture, INSOL International, and, a Fellow of the Nigerian Institute of Chartered Arbitrators as well as an Associate of the Chartered Institute of Taxation of Nigeria (CITN) and the Business Recovery and Insolvency Practitioners Association of Nigeria (BRIPAN).

The learned silk is a lover of football and judo. He is married to Folasade Ohwovoriole; President of the Area Customary Court, Asaba, Delta State and they are the proud parents of intelligent and God-fearing children.

Prof. Donatus Omofuma Akhilomen

Prof. Donatus Omofuma Akhilomen is a Professor of Church History in the Department of Religious Management and Cultural Studies, Faculty of Arts in Ambrose Alli University, Ekpoma. He graduated from the then Bendel State University, Ekpoma in the Department of Religious Studies and Philosophy in 1988. As a promising academic, he was employed by the University as a Graduate Assistant in 1989 after his completion of the mandatory NYSC. He thereafter enrolled for Post Graduate Studies and obtained M.A. Degree and Ph.D in Church History in 1993 and 1999 respectively.

Prof. Don. as he is fondly called by many has held so many academic and administrative positions within and outside the University; the most recent being the Dean, Students' Affair Division, Ambrose Alli University (2016 - 2019). Till date he is still referred to as the "Digital Dean of Students" for his several



innovations that brought about the digitalization of the Division. Prof. Don Omofuma Akhilomen is a happily married man who is blessed with children.

Mrs. Betty Oluwasina is a trained lawyer and a seasoned banker with well over 29 years' experience in the banking sector.

She had a stint in private law practice from 1987 to 1989 before joining the Central Bank of Nigeria in 1989 where she retired from in June 2006. Her well over 16 year career at the CBN took her through different strategic departments in the Organization, acquiring and garnering invaluable experience in administration, international trade and foreign exchange management through policies formation. She delivered a number of papers on international trade documentations, controls and foreign exchange guidelines in various financial institutions. She was also a bank examiner in the Other Financial Institutions Department (OFISD) where she led various teams to Community Banks (now microfinance banks). Primary Mortgage Institutions, Finance Companies and Bureau de Change for examination and supervision.

In her quest to drive her passion of empowerment of the less privileged, she established Capstone Microfinance Bank Limited in June 2008 as a vehicle to achieve this aim. She has an earnest passion to empower women particularly the widows. This drive necessitated the setting up of a product in her bank called the Seed Capital for Widows. They have empowered over four thousand widows to date.

She has contributed immensely to the stability of the Microfinance banking Subsector and had played active role as Trustee of The National Association Of microfinance Bank in Nigeria. Mrs. Oluwasina obtained a Bachelors of Law Degree (LL.B) from the University of Benin in 1986. She thereafter proceeded to the University of Lagos for a Master Degree in Law (LL.M) graduating with

a distinction in International Economic Law in 1989. She obtained a Masters in Business Administration (MBA) from the University of Lagos in 1994, specializing in Management and Marketing. In the course of her banking career, she has

attended various courses locally and internationally.

She belongs to a number of professional bodies, which includes The Nigerian Bar Association (NBA), Nigerian Institute of Management (NIM), Institute of Certified Economics of Nigeria (ICEN), Women in Banking and Finance (WIBAFEM), International Federation of Women Lawyers (FIDA) and Chartered Institute of Bankers of Nigeria (CIBN).
